# **Review/Approve of Minutes:**

Darla made a motion to accept the Minutes for the September meeting, Caryn 2<sup>nd</sup> the motion, all approved.

#### **Financial Report:**

As of September 30<sup>th</sup>; Our checking account has \$162,263.05 and our savings account has \$268,761.72 for a total of \$431,024.77.

Our September expenses were Administration \$5,856.60, Insurance \$3,847.00, Accounting fees, Utilities and Station & Grounds. The Operating Expenses were \$600.00, No Capital Outlay expenses. Total Expenses for September were \$6,456.60. Our net income for September was -\$2,771.61. Nancy made a motion to accept the financial report as received, Dan 2<sup>nd</sup>, all approved.

### **Chief's Report:**

Chief Bobby Hill reported we had 109 calls through the end of September, and an additional 3 calls by today.

The fatal fire in Piney Knolls of the camper explosion is still under investigation.

The training this past month at Red Feather Excavation's work yard practicing Auto Extrication training. We practiced using the new auto extrication equipment, it works great.

The state grant we were hoping to use for new bunker gear for our new members and more SCBA equipment, we didn't get this year.

Fire Prevention Week (Oct. 8-14) was scheduled for this Thursday, but with a forecast of snow and cold weather, it has been rescheduled to next week Wednesday Oct. 18<sup>th</sup>.

#### **Supporter's Report:**

Gerry Wagner the Supporter's President; We received \$300.00 from recent donations. We bought a credit card machine for Fire Days, it cost \$715.00. We haven't totaled the 2023 Fire Days income/expense yet. Caryn and Gerry will get together to get that done.

## **OLD BUSINESS**

#### Microgrid/generator

Gerry is the point of contact for the microgrid. John who was up here servicing the microgrid's Tesla battery, said he thought wrapping the propane line from the tank to the generator with heat tape was a possibility. Gerry said he would talk to Scott at Schrader Propane about this.

#### **FPPA**

Caryn has been working with Ahni Smith with FPPA, gathering information from her about increasing our Fire Fighters Pension Plan.

Below are the proposed plans, we are discussing (pg. 26 of 29). This is the sentence that we feel we need to read the report again to understand better.

"For example, if Red Feather Lakes were to adopt Plan A below, the Net Pension Liability and Pension Expense would increase by at least \$54,870" (Taken from pg. 22 of the report).

Caryn had sent the budget out to us before the board meeting, for us to look it over and be ready with comments and questions. We went over the budget, where there were concerns.
